

# Silver Crest Elementary 2025-26

## Map & Text Description of Safe Walking Routes



**AREA 1:** Walk north to the south side of 12900 S. Walk east to Elementary Drive and cross with the crossing guard to the school.

**AREA 2:** Walk south, east, or west to Bellagio Way. **Residents on the west side of Bellagio Way** walk south on the west side of Bellagio Way and cross with the crossing guard at 12900 S. and then walk to the school. **Residents on the east side of Bellagio Way** walk south on the east side of Bellagio Way and cross with the crossing guard, first at Bellagio Way, and then across 12900 S. and continue walking to the school.

**AREA 3:** Walk south to Herriman Main Street. Stay on the north side of Herriman Main Street and walk west on the north side of Herriman Main Street. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 4: Residents on the west side of Area 4** walk north on Brundisi Way to Herriman Main Street and walk west on the south side of Herriman Main Street to the crosswalk at Black Locust Way. Cross Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**Residents on the east side of Area 4** walk south, north or west to Bobcat Dr. Walk west to Herriman Main Street using the trail at the open green space located at the K9 Memorial Dog Park. Walk north on the south side of Herriman Main Street to the crosswalk at Black Locust Way. Cross Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 5: Residents on the east side of Summerdale Drive/Brundisi Way** will walk on the east side of Summerdale Drive/Brundisi Way to Herriman Main St and cross with the crossing guard at Brundisi Way. Walk west on the south side of Herriman Main St. up to Black Locust. Cross Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**Residents on the west side of Summerdale Drive/Brundisi Way** will walk on the west side of Summerdale Drive/Brundisi Way to Fort Herriman Parkway. Walk north on the east side of Fort Herriman Parkway and cross at the stop sign to J. Lynn Crane Park. Walk on the east side of Black Locust Way to Herriman Main Street. Cross Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 6:** Walk west, south or north to Birkin Wood Lane. Walk west on Birkin Wood Lane to Fort Herriman Parkway. Walk north on the east side of Fort Herriman Parkway and cross at the stop sign to J. Lynn Crane Park. Walk on the east side of Black Locust Way to Herriman Main Street. Cross Black Locust Way and Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 7:** Walk east to Fort Herriman Parkway. Stay on the west side of Fort Herriman Parkway and walk north. Cross at the stop sign to J. Lynn Crane Park. Walk on the east side of Black Locust Way to Herriman Main Street. Cross Black Locust Way and Herriman Main Street with

the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 8:** Walk north or west to Herriman Rose Blvd. Walk north on the east side of Herriman Rose Blvd. and then walk east along the south side of Herriman Main St to the crosswalk at Black Locust Way. Cross Herriman Main Street with the crossing guards. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 9:** Walk north or east to Herriman Rose Blvd. Stay on the west side of Herriman Rose Blvd and walk north to Herriman Main St. Cross Herriman Rose Blvd with the crossing guard and continue walking east along the south side of Herriman Main St to the crosswalk at Black Locust Way. Cross with the crossing guard across Herriman Main St and then walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**AREA 10: Residents in the north side of Area 10,** walk north and east to the open green space located at the northeast end of the neighborhood. Walk along the sidewalk in the green space and through the gate to Herriman Main St. Walk east on the south side of Herriman Main St to Herriman Rose Blvd. Cross with the crossing guard at Herriman Rose Blvd and continue walking east along the south side of Herriman Main St to Black Locust Way. Cross with the crossing guard across Herriman Main St and then walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school.

**Residents in the south side of Area 10,** walk north and east to the HOA park on Woods Park Dr. Walk East on the park sidewalk and through the gate on the east side of the park. Walk east on Meadows Dr, then turn left and walk north on the west side of Herriman Rose Blvd. Cross with the crossing guard across Herriman Rose Blvd and walk east on the south side of Herriman Main St to the crosswalk on Black Locust Way. Cross with the crossing guard across Herriman Main St. Walk west along the north side of Herriman Main St. Cross with the crossing guard past the entrance to the county library/rec center and continue to the school."
