1. Approval of minutes from Sept. 18, 2014 meeting Motion to approve by Shannon, second by Jerri. All in favor.

2. Safe Walking Route plan for the 2015-2016 school year

Discussion of concerns voiced on the spreadsheet, collected from community survey, and concerns voiced to SCC members. After much discussion about laws and wishes the following changes are being submitted to the Police Department to see if they are possible. They ARE NOT for sure changes at this point. They are simply our requests. We will be updated at our next meeting as to what can legally be done.

Silver Crest Elementary – Safe Walking Route Draft (11/17/14)

Area 5. If you live in area 5 walk east or south to West Evening View Drive. Walk east to South Evening View Drive. Then walk south to Salerno Street (5561). Go east on Salerno Street to 5600 W. Cross with the crossing guard to the east side of 5600 W. Then go south to 12900 S. Turn east on 12900 S. and walk to the crosswalk on Elementary Drive. Cross with the crossing guard to the school.

Area 6. If you live in Area 6, walk east or west to Bellagio Way. Residents on the **east side of Bellagio Way** will walk south on the east side of Bellagio Way past the Rec Center Driveway to the South Side of 12900 S. Then walk west to the school. Residents on the **west side of Bellagio Way** will walk south on the west side of Bellagio Way to 12900 S., staying on the North side of 12900 S. walk west to the to the crosswalk on Elementary Drive. Cross with the crossing guard to the school.

Area 8. If you live in Area 8, walk to Ashfield Drive then walk south-west to Brundisi Way. Walk south on Brundisi Way to Herriman Main Street. Stay on the north side of Herriman Main Street, through the Rec Center Driveway, until you get to the school.

Area 9. Can the crossing guard at 12600 and Herriman Main Street cross to the south and to the east (10 lanes) if so we would like to route the kids to the southwest corner of Herriman Main Street and let them meet up with group 8 on Ashfield street.

-We will address Area #3 later in the year as we see kids moving in.

3. School Pictures

A brief discussion took place regarding Lifetouch and Eastman Adams. A few parents voiced concerns about the quality of pictures from Lifetouch but prices seemed similar. Amanda is going to talk to Rob, Lifetouch Rep, about the few concerns and we will revisit this at our next meeting if we have any feedback from the community. If not we will stay with Lifetouch.

4. Emergency Kits

Bruce reported that WalMart is unable to help us with the kits. Shannon and Amanda are going to get the items for the kits out of the storage shed and see the size of carton we need to put things in. Bethany has recruited neighbors to help with shopping for the items we still need to purchase. We set a timeline to have the kits completely finished by January 30, 2015.

5. SAGE Data

Amanda shared SAGE data in regards to Silver Crest, Jordan School District, and the State of Utah. We talked about not being able to compare SAGE To CRT results and what we are doing at Silver Crest to better prepare our students for the SAGE test. We also had a discussion about curriculum vs. standards and the good that will come from having higher standards.

Also discussed: Limiting Skylerts to one per day, Amanda will talk with the administrative assistants and be aware as we schedule them to go out. We will also link the safe walking (SNAP) plan to our website.
